 - a. Warm Springs Alliance: Sylvia Nibley, Community Builder & Board Chair, would like to come to a meeting. The group is advocating for the use of the Warm Springs Building (on the 800 block of 300 West) as a public meeting space / art space.
 - b. Bryant Middle School principal Larry Madden would like to come to a meeting to present about the Bryant / Salt Lake Center for Science Education (SLCSE) partnership. (Coordinate through Janet Barnett.)
 - c. Also consider giving Katherine Kennedy dedicated time during this meeting focused on education
 - d. GACC Finance Michael needs 10 minutes to review the 2018 actuals.
- 5. Decide on Newsletter Items

 - b. Article from Bryant principal Larry Madden
 - c. Street Fair: initial call for artists, ask for volunteers to be on the committee, with the first meeting scheduled in March no experience needed!

 - g. Wasatch Alliance would like to recruit members in the community. They can write an article for the newsletter inviting people to join; however, because they are a for-profit organization, they would need to pay for advertisement space for anything related to making a profit.
- 6. Other Business Discussion of future meetings this year
 - a. Parks Department there is a meeting scheduled for January 23, but it may be postponed, since it hasn't been presented to the Advisory Council yet. Invite them to a GACC General Meeting? It would be about 20 minutes for their presentation, plus time for questions.
 - b. Fire Department has new equipment for use on the trails. Possibly invite them to come to the same meeting as the Parks Department.
 - c. Mayoral debate will there need to be two nights? Timing: while there will still be time before voting *ends* at the August meeting, some people may have already completed their voting. June meeting is still during the window to sign up. Plan for July 3 meeting only.
 - d. Affordable Housing/Homelessness May meeting? Or June?
 - i. The Road Home will close in July. There was a recent article in Deseret News, including updates from Jackie Biskupski, about the issue.

- ii. The new ADU policy in SLC when is it being implemented? Are there data points about how much it is used and then how affordable they are?

- e. GACC Communication Strategy
 - i. Addendum we need to improve our content and consistency
 - 1. We can include content/updates from the City newsletter and from Chris Wharton's emails.

 - ii. There is a clear difference between The Agenda (which everyone gets, regardless) versus Facebook live and website (where people need to actively seek out content).
