Phil Carroll made a motion to upgrade for at least 2 months. We would then decide if we wanted to do it for a year which was \$780. Jill Van Langeveld Seconded it. The motion passed
- Received billing from 3rd Sun for \$600 for web site annual maintenance agreement.
- Michael puts GACC announcement on Next Door and Facebook and Dave puts it on the Webpage.

• Michael is in the midst of refunding booth application money for the cancelled 2020 Street Fair. Approximately 30 applications had paid for a booth space.

Alan Hayes talked about the Red Tail nesting areas and the 4 chicks that hatched this year and stressed that the welfare of wild animals that live in the area should a consideration in peoples' votes.
- Ivory Homes representative Christopher Gamuroules spoke about the changes they have been making with the architects after the many comments given at the GACC General meeting July 1st. They will be continuing to listen to suggestions form concerned neighbors. They have done traffic analysis and wildlife analysis and would love to come again the the General Meeting to share changes.
