Chair's Message for September

I know it seems that we're always in Election season, but we're closing in on Local Election Season. If all politics is local, then we're at the forefront now. There are two elections this year that I want to bring to your attention. The first is for the District 3 City Council position, which represents the Avenues and Capitol Hill areas. The second election is for the GACC officers and Board.



At our General Meeting in August, we learned about the Utah Independent Redistricting Commission. This is the body that was formed as a result of Referendum #4 of 2018. It's an attempt to minimize the gerrymandering that we typically see in many of our state-level districts. The affected Districts will include Utah's congressional districts, and also our State Representatives and Senators and even the State Board of Education representatives. At our September General Meeting, we will have a presentation on Ranked Choice Voting. This year's City Council races will be the first in Salt Lake City to use Ranked Choice Voting. As a result, there will not be a primary this year. Instead all candidates will be on the ballot and voters will rank their preferences. As of our newsletter deadline, the declaration period is still open, so we don't officially know how many candidates we will have running.

At our October General Meeting, we will have a Candidate Night. We will invite all of the declared candidates for District 3 and ask each of them questions about their vision for Salt Lake City and the Avenues. This will be a Zoom meeting, so we won't have the same opportunity for interpersonal discussion afterwards. But it will be a good opportunity to see all of the candidates side by side. If you have a question that you'd like to see discussed, please email it to gaccchair@slc-avenues.org. We probably will not be able to address all the questions, but we'll try to at least get to the most frequently asked ones.

We also have our GACC Officer and Board elections. Our Chair Elect, Gwen Springmeyer, will take over as Chair for 2022.

We'll need to elect a new Chair Elect, as well as Secretary and Treasurer. As normal, we will have some Board members that will elect not to return next year. The Board meets monthly and is tasked with developing the agenda for the monthly general meetings, as well as general oversight of activities such as the Avenues Street Fair, the Memory Grove Clean-up and other committees.

This year, we had over 1200 people cast ballots in an on-line vote on a zoning issue. We had over 100 people at several meetings this year. We've started new committees to address potential wildfire readiness and to grow and protect our urban tree canopy.

I ask that if you've been involved in any of these events, please consider joining the Board or running for office. If you have any questions, please contact Laura Cushman at gaccpastchair@slc-avenues.org.

The 2021 Avenues Street Fair will be on 9th Avenue between D and I Streets on Saturday, 11 September from 9 AM until 6 PM.

All information is correct as of press time in mid-August. Please check the Street Fair website at www.avenuesstreet-fair.org for updated information. Any changes due to Covid, weather, or any other factors will be noted there.

The Children's Parade begins at 9 AM. Please meet at the corner of I Street and 9th Avenue at 8:45. Kids are encouraged to dress up in costume and walk, ride a bike or scooter, or get pulled in a wagon. Parents, Grandparents, and pets (on a leash) are welcome.

We will have a **Bike Valet service** near our West Stage at 9th Avenue and D Street. Ride your bike to the Street Fair and park it safely at the Bike Valet station while you attend the Fair!

ADA drop-off areas will be behind the East Stage at I Street and 9th Avenue, and behind the West Stage at D Street and 9th Avenue. For all ADA accommodations, please call Dave Alderman at 281-435-9080.

Our Featured Artist this year is Avenues resident Mark Walton, whose work is on the poster and logo of this year's Fair. Please visit Mark's booth near the center of the Fair, on the South Side of 9th Avenue, between F and G Streets, adjacent to the GACC Headquarters booth. TOTALS ARE IN from the *Friends of the Cemetery volunteer cleanup* to help the Cemetery Go Green. Each Memorial Day, potted plants, flowers, and artificial arrangements are placed around the graves of loved ones by families. These items are removed by Cemetery staff one week after Memorial Day. This is no small feat! This year, members of the community volunteered to help the Friends of the Cemetery separate the plants and flowers (the green waste) from the plant pots (the recyclable waste) and the non-recycle artificial flowers and foil/plastic wrap (trash). During the events, volunteers:


- GATHERED A WHOPPING 17,480 POUNDS - NEARLY 9 TONS - OF GREEN WASTE (potted plants and dead flowers). This will all be composted by Salt Lake City and diverts 17,480 pounds of waste from the landfill!
- FILLED A TOTAL OF 75 BLUE RECYCLING BINS with plant pots. This is estimated to be as much as 11,250 pounds – or almost 6 tons - diverted from the Salt Lake City Landfill.
- COLLECTED 23,820 POUNDS - ALMOST 12 TONS- OF GARBAGE! This includes non-recycle artificial flowers, plastic plant wraps, labels, ribbons, and foil. This equates to the size of the largest elephant on record!!

For perspective, the **EPA estimates** that the average person generates 4.9 pounds of waste per day, including garbage, recycling, and compost. The cleanup totals

also highlight the '3 Rs' of Reduce, Reuse, Recycle. While the cleanup events were able to divert over 14 tons of waste from the landfill, through a combination of Recycle and composting, there are opportunities to both Reduce and Reuse:

- One option to Reduce is by choosing plants in compostable plant pots instead of plastic potted plants, artificial flowers, foil or plastic wrapped plants and flowers.
- One option to Reuse is by coordinating with a wholesale garden center to collect and reuse plastic plant pots. The Friends group will explore this option.

Finally, we would like to thank every volunteer who contributed...these cleanup events, and the amount of recycling and green waste diverted from the landfill, would not have happened without **YOU**. We would also like to thank the Salt Lake City Cemetery staff for their support during this event.

Get to Know Your New SLC Airport



The New SLC airport provides passengers with an entirely new experience from curb to gate.

It has been nearly a year since the Salt Lake City

Department of Airports (SLCDA) turned the key and opened Phase 1 of The New SLC Airport. Early morning on Sept. 15, the lights dimmed on the original 1960s airport and brightened on a new parking garage, gateway center, terminal and Concourse A-west, where Delta Air Lines occupies 25 gates. Six weeks later—on Oct. 27—Concourse B-west opened with 21 gates for Alaska, American, Delta, Frontier, JetBlue, Southwest and United airlines.

A 990-ft. long tunnel—originally built in 2004—connects concourses A and B where passengers experience Utah's four-season murals as they make their way through the passageway. Salt Lake City-based artist Tracy O'Very Covey painted summer and fall, while Texas-based artist Daas painted winter and spring.

"This day has been years in the making," said SLCDA Executive Director Bill Wyatt, on opening day. "To say we are excited to be here today is an understatement. After six years of construction and many more years of planning, we are proud to open the first new U.S. hub airport in the 21st Century," Wyatt added.

The need to build a new SLC airport became apparent as passenger numbers grew and facilities became outdated. Prior to the pandemic, SLC recorded more than 26 million passengers in 2019, in an airport that was built for 10 million passengers.

The advantages of building an entirely new airport are that architects were able to design for the future to create a more efficient and more sustainable facility. The new concourses were designed in a parallel configuration for today's larger aircraft—compared to the previous pier layout built for smaller planes—

which eliminates aircraft bottlenecks and idling, so airlines are able to get their planes to the gate and back in the air quicker.

Request for Special Exception on Tomahawk Drive

The GACC has received notice from the Planning Division of a request to construct a new single-family home at 1484 E. Tomahawk Drive that exceeds the maximum permitted building height of 28 feet and maximum allowable grade changes of 4 feet in the required yards and 6 feet in the buildable area. The property is currently undeveloped.

The Planning Commission has final decision-making authority for special exceptions. A public hearing with the Planning Commission has not yet been scheduled, but is likely to be in September.

Air Quality: Do masks help at all?

We spent a week in Little Cottonwood Canyon in August. We were there on Sunday, 8-1, watching through windows as the rain pelted us and closed both Big and Little Cottonwood canyons, stranding two of our children and their families overnight. While packing the car to drive back home the following Friday morning, 8-6, I could smell the wonderful sweet scent of trees and wild flowers. As we began driving down the canyon, we noticed the Oquirrh Mountains had disappeared. At the bottom of the canyon, we couldn't see Sugarhouse let alone The Avenues. When we arrived home it smelled like a campfire. Yuck! What was happening?

Saturday, 8-7, Salt Lake City and Denver made the national news for the *worst air in the world* because of the huge wildfires in California. Wild fires are increasing in frequency and intensity and as long as we have wildfires burning, we will need to continue to deal with the smoke carried by winds from surrounding states. We spent several days in the red zone – unhealthy for everyone.

Our top priority still remains to *prevent* air pollution in the first place, but what do we do when it comes to us?

Well . . . File this under *department of silver linings*. While you are probably already experiencing **severe mask fatigue**, and the thought of having to cover up is as exhausting as it is unavoidable, there is an extra health benefit you may not have anticipated. Yep, masks might help protect you against some of the health risks of exposure to air pollution and wildfire smoke. The list of conditions and illnesses that have been linked to air pollution is excruciatingly long. But, it turns out that masks actually offer some measure of protection. How beneficial is the average mask and are all types equally effective against pollution?

Richard Peltier, Associate Professor of Environmental Health Science at the University of Massachusetts Amherst, breaks it down. *"If we're talking about what we call ambient air pollution-that's the stuff that comes out of factories and the tailpipes of cars and trucks-the answer is yes. When you're wearing an N95 mask (or a KN95 mask, which is the Chinese equivalent), the masks actually do protect you. They do a pretty good job of filtering out the smallest particles."*


When you move to the low-tech solutions-the cloth masks and bandanas, or surgical masks-these often have very little effect because the particles are so small, and they can pass right through those fibers in a surgical mask or that cloth mask. That doesn't mean that they provide zero protection though. We did a study in 2016 looking at that-it's on an order of 15 to 30 percent of the particles blocked. So a cloth mask is better than nothing".

IQAir is a Swiss-based air quality technology company which works with individuals, organizations and communities to breathe clean air through information and collaboration since 1963. This is their assessment published July 26, 2021:

The most effective masks include: N95: NIOSH-42CFR84 (United States), KN95: GB2626-2006 (China) and FFP2: EN 149-2001 (Europe). These masks are generally tested for 95% efficacy against the following airborne particles: PM10, PM2.5, bacteria, viruses (both large droplets and tiny aerosols), pollen, and household dust. Along with filtration efficacy, a mask's seal is arguably the most important element of an effective mask.

N95 masks are hard to find but the KN95s can be found easily online. Go to your favorite browser and ask "NBC 7 best KN95 face masks and where to buy them online" or something close. Lots of good info.

In the last year and a half we've learned a lot about SARS-CoV-2 and its variants, masks, and ourselves. Much of what we thought we knew in March of 2020 has changed 180 degrees. That's the thing about science. People keep asking questions and other people keep finding the answers. I found a history book on my grandfather's bookshelf printed in 1934. It had a photo of the Graf Zeppelin airship, which flew around the world in from August 7 to September 4, 1929. The caption beneath the photo asked, "Do you think air travel will ever replace steamship travel?" *Science* again; you can't get away from it.

Each year, the Avenues Street Fair Committee selects a local artist to create an original painting or digital work of art that represents the artist's concept of what "the Avenues" means to them. Their creation becomes the official promotional art for the Fair.

We are excited to announce this year's Featured Artist: Mark Walton, a freelance storyboard artist living with his family in the Avenues, where he grew up. 
