### **Trails in our Foothills**

In January 2021, the GACC Agenda newsletter had an article about implementing the SLC Foothill Trails Master Plan. The article conveyed a message of progress and excitement. At the July 2021 Community Meeting, Lewis Kogan from SLC Trails talked about the

parts of the plan completed and the next steps. Dan Schelling from Save Our Foothills explained why the City should stop construction and reevaluate the plan. The City then paused trail construction and implemented a process to revisit the trails plans. Recently, the City extended the pause to the fall of 2023.

In 2022, we have enjoyed numerous articles about our Foothills. We learned about the importance of our foothills, the unique geology, the fantastic wildflowers, the benefit of ants, and the value of the Gambel Oaks. We who live in the Avenues are incredibly fortunate to be near the foothills and to be able to access and enjoy this exceptional natural resource. We all should ask ourselves what we believe to be the best plan to provide access and protection simultaneously.

At the GACC July 2022 Community Meeting we will hear from Tyler Fonarrow, from SLC Trails, Dan Schelling, from SOF, and Kenton Peters, from the SLC Trails Alliance. Dan and Kenton will provide different views on the location, number of trails, and plans to protect the foothills. # Save Our Foothills: Environmental Preservation for Now and for Our Future

Save Our Foothills is a citizen campaign that came together in 2021 to advocate for the conservation and preservation of the Salt Lake City Foothills. The Foothills provide essential wildlife habitat, watersheds, and open space for all to enjoy. Our mission is to ensure the preservation of the Salt Lake City Foothills ecosystems, and the remarkable biodiversity that resides here, for the enjoyment and health of all visitors. Our immediate goals are to encourage Salt Lake City to develop science-based land use and recreation management plans for the Foothills, thus ensuring that these natural environments

are maintained into perpetuity. Save Our Foothills believes long-term sustainability is possible through public engagement and intelligent decision-making. Detailed field research is required to understand and protect plants, wildlife, soils, water, and to understand the impact of recreational activities. Additionally, we need comprehensive cultural and historical studies to understand and appreciate how these lands have been used, altered, and cared for by Native American stewards for millennia.

With an appropriate and comprehensive data-set, and an assess-ment of community values, Salt Lake City will be equipped to develop a regional land use management plan. This will then allow Salt Lake City to develop a recreational management plan that prioritizes environmental preservation while allowing inclusive and equitable access to the Foothills-and to do this in a manner that will serve residents for generations to come. As citizens we can all agree that recreational development should enhance rather than degrade the natural characteristics of the Foothills.

We are incredibly fortunate to live in close proximity to wilderness quality lands that provide us with immeasurable physical, mental and emotional benefits. In our enthusiasm to increase recreational opportunities, however, we must not take them for granted. We need to acknowledge that these lands are fragile, easily erode, and recognize that this arid environment is slow or sometimes unable to recover from damage. As Salt Lake City moves forward it is our collective responsibility to ensure that we leave a legacy for the future that includes beautiful, unscarred viewscapes, intact habitats, and meadows blooming with native wildflowers.

Save Our Foothills is ready to assist Salt Lake City to realize a vision for equitable and responsible enjoyment of the Foothills. Opportunities await, however prior to any development adequate protections for the Foothill natural environments must be defined and in place. We must also embrace outdoor etiquette and education. We have but one chance to do this right. Let's take the time we need, rise to the occasion, and constructively meet this challenge.

### Salt Lake City Foothills Trail System Plan

In June 2021, Public Lands submitted an article to GACC with a summary of Phase I of the Foothills Plan and its goals for evaluation before proceeding into Phase II. The analysis produced a tremendous amount of insight and information to achieve the plan's goals that balance land conservation with sustainable recreation. SLC staff has met with Save Our Foothills (SOF) and SLC Trails Alliance (SLCTA) several times to learn not just about their goals or concerns but to glean helpful information that will help us make more informed decisions.

The City has also committed to recruiting experts to evaluate and give feedback on Phase I implementation and the plans for Phase II. SWCA was hired in December 2021 to gather ecological and cultural analytics of trail corridors and designated "habitat study areas" within the Foothills. They have been actively engaging with local agencies to compile an inventory of factors to be considered and will present their findings and recommendations later this year. After an initial RFP for a trails plan evaluation this winter was cancelled due to insufficient responses, a more robust and detailed RFP was put out in the spring. A firm with extensive planning and trail design experience in wilderness and conservation areas has been selected but is still confidential until the contracts are signed later in June. Their consultation will run summer 2022 through summer 2023, leading to the possibility of Phase II implementation as early as fall 2023 or 2024.

While design and construction lay the foundation for a successful trail system, equally important are its users' behaviors and trail culture. With the abundance of new users recreating in the Foothills, combined with the historical lack of oversight of regulations by its land managers (SLC, State, USFS), it is more critical than ever to work together to determine agreed-upon trail use guidelines and how best to educate the public on best practices on complex issues such as dogs, e-bikes, and land sustainability. There are successful models around the country where these "education and etiquette" campaigns have brought together conflicting organizations to find common goals and a more collaborative co-existence. It is the hope of SLC Public Lands that we can partner with groups like SOF, SLCTA, conservation leader Save Our Canyons, and the exploding number of mountain biking teams, riders, and hikers to come together to find a reasonable solution to protect our foothills and keep our trail users safe and happy.

### The Salt Lake City Trails Alliance

After spending five years laying the groundwork for a successful implementation phase of the Salt Lake City Foothills Trail System Plan, in March of 2020, the Salt Lake City Council formally approved the plan. Construction began in the summer of 2020, just as COVID-19 had begun to upend our lives, making this trail system even more critical to our residents and visitors.

Despite extensive engagement and planning efforts, phase 1 of construction surprised some, who expressed concern and outrage to city officials at the building of these first trails. In response, Mayor Mendenhall paused further construction for several months and then extended the pause for an entire year

so consultants could assess the issues. Nearly one year after the initial pause, the consultants still have not been hired. Thus, Parks and Public Lands staff recently asked the City Council to extend the construction pause for another year to June 2023.

Local citizens formed the Salt Lake City Trails Alliance to understand the pause and advocate for a well-planned network of foothills trails to provide quality recreation opportunities for a broad range of non-motorized users. As a group of volunteers, we are willing to roll up our sleeves to help with the implementation, maintenance, or advocacy of an intentionally-designed trails system. We promote the idea

that trails close to home reduce driving - save valuable time and money – while benefiting air quality and climate change. To move forward successfully, we understand and support Salt Lake City's acknowledgment the implementation of the first phase of the plan did have some problems, and we support the city's commitment to addressing these. However, we also believe the fundamentals of the approved trails plan are solid, and the plan's implementation should continue. As we are now in our third construction pause for this project, we are concerned the future approved phases will be postponed indefinitely. As Salt Lake City taxpayers, we request a firm deadline for the completion of the consultants' studies, a publicly-stated date when Salt Lake City will announce proposed new trails, and a firm date for starting construction.

Having a defined and firm schedule will help all lovers of the foothills regain the trust that Salt Lake City will move forward with new, sustainable trails built for all users. Using the excellent examples set by our neighbors in Park City, Draper, Herriman, and other Utah towns, we look forward to working with Salt Lake City to expand and sustain the trail system that our world-class city deserves.





### **Ozone – Our Summer Air Quality Problem**

We have two types of ozone.


repellents, dry cleaning, air fresheners,

essential oils.

•*Stratospheric ozone* is the good ozone which occurs naturally in the upper atmosphere. It forms a protective layer that shields us from the sun's harmful ultraviolet rays.

•*Tropospheric ozone* is ground-level ozone which is unhealthy to breathe. Many factors impact ground-level ozone development, including temperature, wind speed and direction, time of day, and driving patterns. Due to its dependence on weather conditions, ozone is typically a summertime pollutant and a chief component of summertime smog.

Heat from the sun is necessary for the formation of tropospheric ozone, so if you need to use products which release VOCs (Volatile Organic Compounds) or drive a gas/diesel fuel car which releases NOx (Nitric Oxides) during combustion, try to do it in the cool of the mornings so that the fumes have dissipated before the afternoon sun can change them into unhealthy air we really don't want to breathe.



### 200 Volunteers Clean-up SLC Cemetery

Each year, in observance of Memorial Day, visitors to the Salt Lake City Cemetery place potted plants, flowers, and other memorabilia around the graves of their loved ones. Once the flowers and plants have died, they need to be removed. For the second year, the Friends of the Salt Lake City Cemetery and the SLC Cemetery staff organized a volunteer event to collect and separate the plants and flowers (compostable waste) from the plant pots (recyclable waste) and the foil and plastic wrap (trash).

Approximately 200 volunteers helped over the three days of the clean-up on June 8, 9, and 11. We had volunteers from as far north as Hill Air Force Base and as far south as Provo.

At press time, we don't have the totals for how much was collected. But last year, nearly 9 tons of green waste was diverted from the landfill to be composted. Almost 6 tons of plastic were recycled rather than sent to the landfill. All of this would have been sent to the landfill in previous years.

This was an excellent opportunity to support our cemetery, enjoy the green space, meet neighbors, and contribute to the community.

**Memory Grove Park and City Creek Parks** are both a beloved part of the Avenues Community. The Memory Grove Foundation, originally formed in 1974, has been instrumental in advocating for the improvement of the Greenway which starts at State Street with City Creek Park and continues through Memory Grove. MGF has been accepted by the GACC Board of Directors as an official GACC Committee.

MGF started by developing the trail and information monuments in conjunction with the U.S.A. Bicentennial Commission in 1976. It played a role in reclaiming the Greenway after major flooding on City Creek in 1983. It again played a key role in redesigning and reshaping Memory Grove after the 1999 tornado. It was dormant until 2018 when it was reconstituted to work with the Salt Lake City Department of Public Utilities to install a new pump house and treatment facility in City Creek Parks.

### Environmental Tips

Be cool! It is officially Summer and record high temperatures are expected. Make sure you replace your furnace filter(s) or evaporative cooler pads. Ideally, set your thermostat at 78° when home and 85° while away. A "Smart Thermostat" can save you 10-20% on your electric bill. Closing your blinds and avoiding the use of appliances that heat up your home can also lower your bills substantially. If possible, consider solar panels to minimize your A/C bill and a strain on the power grid.



#### Capitol Park Cottages at 675 North F Sstreet



The Salt Lake City Planning Commission voted favorably in June for a rezone and master plan amendment at 675 N. F Street.

Ivory Homes wants to build 19 homes on the three acre parcel, 14 of which would have an accessory dwelling unit.

The developer has completed a planned development request for the project. Residents mobilized a multi-year effort to fight the concept for a variety of reasons, and spoke at the Planning Commission meeting for nearly three hours before the commission voted in favor.

The rezone has to be approved by the City Council, who will review the Planning Commission's recommendation in the coming months.

#### Just Weaseling Around the Foothills

Today we would like to give a special shout-out to our tiny but mighty carnivore friend, the *Mustela Frenata*, or long-tailed Weasel, commonly seen in the foothills above the Avenues.



The species is declining in the U.S., and even though it is protected in twenty states, it is vulnerable here in Utah. Utah law permits anyone to kill a weasel deemed a "nuisance."

Additionally, for \$29, trappers can take weasels during five months of the year anywhere in the state with a "no bag limit." Weasels are in decline due to habitat loss, disruptions to snowfall patterns driven by climate change and the use of rodenticides (Lynn Wilson, National Wildlife magazine, vol. 60, No. 2).

Before recent trail development and recreation planning, Salt Lake City managed the City Creek Watershed and adjacent foothills as a de-facto wilderness.

Some species that are declining elsewhere in the state may be thriving here because of lower hunting pressures and protections afforded by the roughly 36,000 acres of naturally intact roadless lands between Parleys Canyon and Bountiful.

Unfortunately, the needs of many native wildlife species, like our cute long-tailed weasels, are at risk because of a lack of awareness and poor planning.

The weasel is a carnivore, and a prolific hunter of mice, voles snakes, and gophers. They will also eat fruits and berries.

In general, weasels are not dangerous to people and usually avoid human contact. However, they will defend themselves against pet dogs and cats using their sharp teeth. Like most wildlife, the pests may also bite people if threatened or trapped. So please leave them be if you see one on our foothill trails.

So how will we protect our weasels and the entire ecosystem they depend upon? As a community, we can protect the Salt Lake City Foothills' natural environment while enhancing recreational opportunities. #### Wildfire Preparation Tips! by Shane Carlson


